# **In Memoriam**

## Edward W. Brooke (1919 - 2015)

he National Low Income Housing Coalition mourns the death of Senator Edward W. Brooke (R-MA), who died on January 3, 2015 at the age of 95. The first African American to be popularly elected to the U.S. Senate, Senator Brooke was a strong advocate for low income and fair housing during his two terms (1966-1978). He and colleague Senator Walter Mondale (D-MN) sponsored the legislation that became the Fair Housing Act of 1968. He was also the author of the "Brooke rule" in 1969 that established the principle that residents of federally assisted housing spend no more than 25% of their income on housing (it was raised to 30% in 1981). His work on housing exemplified his bipartisan approach to legislating. In 2009 Senator Brooke received the Congressional Gold Medal.

From the beginning of the National Low Income Housing Coalition in 1974, Senator Brooke was a close ally and good friend. NLIHC founder Cushing Dolbeare credited Senator Brooke as the Senate lead on provisions that NLIHC urged be included in the 1974 Housing and Community Development Act. As Ranking Member of the Senate Banking Committee during his second term, Senator Brooke was the most important champion for affordable housing in the Senate.

After leaving the Senate in 1979, Senator Brooke served as Chair of the NLIHC Board of Directors, noting that the position "gave me purpose and showed that even though I was no longer in office I could still have a positive impact in the lives of others." In 1982, NLIHC gave Senator Brooke its first housing leadership award. In

2010, NLIHC divided the annual award into two: The Edward W. Brooke Housing Leadership Award and the Cushing N. Dolbeare Lifetime Service Award.

Throughout his post-Senate years, Senator Brooke remained a steadfast friend of NLIHC. He and his wife Anne are among NLIHC's most generous donors. When Cushing Dolbeare died in 2005, Senator Brooke traveled to DC to speak at NLIHC's commemorative event for her. In 2013, he agreed to be the honorary chair of the NLIHC-led United for Homes campaign.

We are honored that the Brooke family designated NLIHC as one of three charities to which they directed donations in memory of Senator Brooke.

# Willie "Peaches" Manning (1937 - 2015)

eaches Manning, a long-time member of the National Low Income Housing Coalition, died on January 3, 2015. For 38 years, Ms. Manning was the Resident Association Coordinator with the Metropolitan Development and Housing Association (MDHA) in Nashville, Tennessee. In that role, Ms. Manning managed resident associations at 19 public housing properties to promote a sense of community and neighborhood involvement among Nashvillians. Before becoming Resident Association Coordinator, she served MDHA as a child development aide for two years.

A native of Nashville, Ms. Manning was revered by many, young and old, particularly the city's public housing residents, many of whom she served as a mentor. Among her many accomplishments, Ms. Manning organized MDHA's 90 Plus Club celebrations, which honored residents over the age of 90, and established MHDA's

scholarship fund for students living in public housing.

In 2012, Ms. Manning was inducted into the Hall of Fame for the Lydia Society, a coming of age organization designed to educate teenage girls living in public housing. She was selected for her work in the community, especially her development of a scholarship

program for them to attend summer camps.

Ms. Manning was a great friend and partner to NLIHC. For many years, she organized delegations of MDHA residents to attend NLIHC's annual housing policy conference and lobby day. NLIHC mourns her passing.

Advocates should have a strong grasp of the NHFT regulations to effectively engage in shaping their states' Allocation Plans for distributing the NHTF dollars and establishing criteria for awarding funds to specific projects. Advocates also need to take action immediately to ensure that the statutorily required funding of the NHTF by the GSEs is not reversed in Congress. Finally, securing more funds for the NHTF through mortgage interest deduction and housing finance reform remains a top priority. # Forum Keynote Speakers

# Julián Castro, HUD Secretary

ulián Castro was sworn in as the 16th Secretary of the U.S. Department of Housing and Urban Development on July 28, 2014. In this role, Secretary Castro oversees 8,000 employees and a budget of \$46 billion, using a performance-driven approach to achieve the Department's mission of expanding opportunity for all Americans. Before HUD, Secretary Castro served as Mayor of the City of San Antonio, where he became known as a national leader in urban development. In 2010, the City launched the "Decade of Downtown," an initiative to spark investment in San Antonio's center city and older neighborhoods, attracting \$350 million in private sector investment to produce more than 2,400 housing units. San Antonio's East Side is the only neighborhood in America that



has received funding to implement major projects under three key Obama Administration revitalization initiatives: Choice Neighborhoods, Promise Neighborhoods, and the Byrne Criminal Justice Program.

In March 2010, Secretary Castro was named to the World Economic Forum's list of Young Global Leaders. Later that year, Time magazine placed him on its "40 under 40" list of rising stars in American politics. Previously, Secretary Castro served as a member of the San Antonio City Council. He is also an attorney and worked at Akin, Gump, Strauss, Hauer & Feld before starting his own practice. Secretary Castro received a B.A. from Stanford University in 1996, and a J.D. from Harvard Law School in 2000.

# Darren Walker, President, Ford Foundation

arren Walker is President of the Ford Foundation, the second largest philanthropy in the United States with over \$11 billion in assets and \$500 million in annual giving. Before being named Ford Foundation President in 2013, Mr. Walker served as the foundation's Vice President for Education, Creativity, and Free Expression, where he shaped annual grantmaking around the world in such areas as media and journalism, arts and culture, sexuality and reproductive health, educational access, and religion. Prior to joining the Ford Foundation in 2010, Mr. Walker was Vice President for Foundation Initiatives at the Rockefeller Foundation, where he led both domestic and global programs in education, civil rights, workforce development, and program related investments.



Earlier in his career, Mr. Walker served as Chief Operating Officer for the Abyssinian Development Corporation in Harlem, NY, where he led efforts to develop more than 1,000 units of affordable housing. He also volunteered at The Children's Storefront, an elementary school serving low-income families in Harlem. Mr. Walker began his career in 1986 at the international law firm of Cleary, Gottlieb, Steen & Hamilton. In 1988, he joined the Union Bank of Switzerland in the capital markets division. Mr. Walker is a 1982 graduate of The University of Texas at Austin and its School of Law in 1986.

Before beginning his career in philanthropy, Mr. Walker served on the Board of Directors of the National Low Income Housing Coalition.
