Dear Senators,

With the mark-up of the Johnson-Crapo housing finance reform bill in the coming days, the Senate Banking Committee has the historic opportunity to make the **largest investment in housing for the poorest Americans** in a generation. We urge you to seize this moment and make sure that the bill passes out of committee with the momentum needed to move forward to a vote on the Senate floor this year.

The bill would assess a ten basis point fee on guaranteed securities, estimated to generate approximately \$5 billion a year when fully implemented. Three quarters would be directed to the National Housing Trust Fund, which must be used to create more rental homes that are affordable to extremely low income households. Today, there are ten million extremely low income renter households and only three million homes available at prices they can afford. This is the **nation's most pressing housing problem** and it is the problem that the National Housing Trust Fund is designed to solve.

We know that you support the National Housing Trust Fund and the bill's provisions that fund it, for which we are very grateful. We also know that you have not yet offered your support for the bill itself. We understand that you have concerns about how well the proposed new housing finance system would serve low and moderate income home buyers, including people of color. These are extremely important issues and we understand and sympathize with your concerns.

We believe it is possible to find common ground to resolve these issues and preserve the bipartisan agreement that Chairman Johnson and Ranking Member Crapo have achieved. In doing so, you would make possible the desperately needed investment in rental housing for extremely low income seniors, veterans, people with disabilities, low wage workers, and families with children who are homeless or at risk of becoming homeless.

For their sake, we **strongly urge you to continue to negotiate** until, together, you craft a bill that you will support. Millions of people are counting on you to keep working until you get to "yes."

This is a moment to do something monumental that rarely is possible today. Please do not let it pass by.
