SUMMARY OF DEADLINES (as of December 6, 2017)

Transitional Sheltering Assistance (TSA)

Texas, January 16. FEMA extended TSA to January 16 (The previous deadline was November 27). However, there is a mid-term eligibility review on December 12 when households participating in TSA will receive a phone call, email, and/or text message advising them if they have continued eligibility for assistance through a TSA participating hotel. The TSA program pays for survivors to stay at hotels while they look for long-term housing.

Florida, January 6. FEMA has extended TSA from December 3 to January 6. Participants will receive a phone call telling them whether they are eligible and what they need to do to remain. Eligible households not currently in the TSA program are automatically notified.

California, **December 7**. People are being temporarily housed in hotels and motels until December 7.

Individual Assistance (IA)

Florida, **November 24**. The deadline to apply for Individual Assistance in Florida is November 24.

Georgia, November 14. People seven counties in Georgia have until November 14 to register with FEMA for Individual Assistance.

Texas, November 30. Residents of the 41 designated counties in Texas have until November 30 to register for FEMA grants (previous deadline was November 24 – the extra six days is added in recognition of Thanksgiving holiday on November 23.)

California, **December 11**. Residents who suffered personal or business losses in the October fires have until December 11 to register for disaster assistance with FEMA.

Puerto Rico, March 20. Applications for the Individuals and Households (IHP), Other Needs Assistance (ONA), Rental Assistance, and Home Repairs are due March 20.

Virgin Islands, December 18. Survivors of both Hurricanes Maria and Irma have until December 18 to register for assistance with FEMA. People may be eligible for grants to repair and rebuild their homes and/or replace essential personal property.

Florida, Applying for Extension of Rental Assistance. (No date specified in October 13 FEMA media release) People registered with FEMA in Florida who are receiving rental assistance through the Individual and Households Program (IHP) may be eligible to apply for continued rental assistance. Rental assistance extensions run for three-month periods not to exceed 18 months from the date of the disaster declaration as long as the household remains eligible.

SBA Low Interest Loans

Florida.

- **November 24**. Physical Property Damage: Renters, homeowners, and nonprofits, and businesses in Florida disaster areas have until November 24 to apply for SBA low-interest loans.
- **June 11**. Economic Injury: The deadline is now June 11.

Puerto Rico, March 20. SBA provides low-interest loans to help homeowners repair or rebuild and renters with property damage expenses as well as with moving and storage and transportation expenses. The deadline to apply is March 20.

November 9. Private nonprofits have until November 9 to apply of low-interest loans to cover physical damage caused by Hurricane Irma.

Georgia, November 14. Renters, homeowners, nonprofits, and businesses in seven Georgia counties have until November 14 to apply for SBA for low-interest loans.

Texas, November 24. Renters, homeowners, nonprofits, and businesses in Texas have until November 24 to apply for SBA for low-interest loans.

California, December 11. Individuals, nonprofits, and businesses have until December 11 to apply to SBA for low-interest loans, <u>according to FEMA</u>. However, according to <u>SBA</u>, nonprofits have until **January 29** to apply for low-interest loans to repair or replace damaged or destroyed property, and until **August 28** to apply for loans to cover for economic injury.

Virgin Islands, December 18. Renters, homeowners, nonprofits, and businesses in the Virgin Islands, whether impacted by Maria or Irma have until December 18 to apply for low-interest SBA loans.

South Carolina.

- **December 4**. Renters, homeowners, nonprofits, and businesses in Beaufort, Colleton, Hampton, and Jasper and counties have until December 4 to apply for SBA low-interest loans.
- **December 15**. Nonprofit organizations in 19 counties have until December 15 to submit disaster loan applications for physical damages caused by Hurricane Irma. The counties are: Abbeville, Allendale, Anderson, Bamberg, Barnwell, Beaufort, Berkeley, Charleston, Colleton, Dorchester, Edgefield, Georgetown, Hampton, Jasper, McCormick, Newberry, Oconee, Pickens and Saluda.

Disaster Unemployment Assistance

Florida, November 14. The previous deadline was October 31.

Virgin Islands, December 29. The deadline is extended to December 29.

Puerto Rico, January 11. Individuals who lost their livelihood because of either Hurricanes Irma or Maria may be eligible for FEMA funded Disaster Unemployment Assistance (DUA). The benefit applies to those who were employees or self-employed. (The previous deadline was November 13.)

Immediate Foreclosure Relief

Texas, February 21. HUD has extended the foreclosure moratorium until February 21.

Florida, March 9. HUD has granted another 90-day moratorium on foreclosures and forbearance on foreclosures of FHA-insured homes.

Puerto Rico, March 9 and March 19. The moratorium on foreclosures expires on March 9 for Hurricane Irma and on March 19 for Hurricane Maria.

Puerto Rico, September 20. Homeowners with FHA insurance whose homes were destroyed and who therefore need to rebuild or purchase a new home have until September 20 to apply for 100% financing.

Public Assistance

Georgia, November 14. Georgia state and local governments, and certain nonprofits, have until November 14 to submit Requests for Public Assistance. The Public Assistance Grant Program provides federal reimbursement of debris removal, emergency protective measures, and repair or replacement of public infrastructure.

Florida, November 21. The deadline for filing Requests for Public Assistance (RPAs) with FEMA to rebuild public infrastructure is extended to November 21. Florida Division of Emergency Management requests state, local, or tribal governments and nonprofit organizations that experienced damage from Hurricane Irma to submit their requests for reimbursement by November 18. Requests received by November 18 will be forwarded to FEMA on or before FEMA's November 21 deadline. The previous deadline was November 5.

Blue Roof

Virgin Islands, November 23. Virgin Island residents have until November 23 to apply for free temporary roofing repairs to their homes through the U.S. Army Corps of Engineers' Operation Blue Roof. (The previous deadline was November 3.)

D-SNAP

Virgin Islands, November 6-9 and 13-15. Virgin Island residents not eligible for USDA's Supplemental Nutrition Assistance Program (SNAP) may apply for Disaster Supplemental Nutrition Assistance (D-SNAP), Monday through Thursday, November 6-9 and Monday through Wednesday, November 13-15. Current SNAP participants do not need to register in order to receive the extra assistance provided by D-SNAP.
