The total differs from \$739.6 million for two reasons. Funds recaptured from some states that missed the statute's requirement to commit funds within two years are reprogrammed to other states for 2022. Due to a rescission provision, each year a percentage has to be removed from the amount transferred to HUD from Fannie and Freddie; however, the amount rescinded from the previous year is restored the following year.
