Our nation's affordable housing faces mounting preservation challenges as the stock grows older

and affordability restrictions expire, impacting the lowest-income tenants most acutely. Key property-level data for assessing preservation risks, however, are often inaccessible to stakeholders, hampering the identification of at-risk buildings and tenants in the short term and preservation planning in the longer term. This panel will examine the current state of data for affordable housing preservation, explore how data can inform organizing and preservation planning, and identify ways that preservation data can be improved at the local, state, and federal levels.

Climate Gentrification and Community Erasure: Are the Themes Highlighted in Razing Liberty Square Coming to a Community Near You? **MONTPELIER**

Liberty City, Miami, was home to one of the oldest segregated public housing projects in the U.S. Now, with rising sea levels, the neighborhood's higher ground has become something else: real-estate gold. Wealthy property owners are pushing inland, creating a speculators' market in an historically Black neighborhood previously ignored by developers and policymakers alike. Razing Liberty Square is a powerful study of the overlapping crises of climate change, systemic racism, and the lack of affordable housing. Join film participants and community members in a conversation about how one frontline community is responding to climate gentrification and erasure.

Building Support for Evidence-Based Homelessness Solutions | SPRINGWOOD

Despite successful efforts to house individuals experiencing homelessness using the Housing First approach, particularly among veterans, homeless systems cannot keep up with the increased inflow due to inadequate funding by Congress. As communities face increasing rates of housing instability and homelessness, there is a growing backlash against people experiencing homelessness and against supporting real solutions to the crisis. This session will examine how advocates can build support for humane, evidence-based homelessness responses despite the worsening affordable housing crisis and growing calls for ineffective and punitive approaches. Panelists will discuss the latest research from the field, including the rigorous evidence supporting the Housing First approach; how Housing First is reducing homelessness among veterans and others; and needed federal investments to fully address the housing and homelessness crises.

Locked Up, Locked Out: Barriers to Housing for Formerly Incarcerated and Convicted People **MONTPELIER**

The United States is the world's largest jailer, incarcerating almost 2 million people in state and federal prisons, jails, juvenile correction facilities, military prisons, and immigration detention facilities. More than 95% of people incarcerated will eventually be released and will return to their communities, but many lack a safe, stable, affordable home to which they can return, increasing their likelihood of experiencing homelessness and ultimately recidivism. This session will lay out the barriers to housing for formerly incarcerated and convicted people, highlight communities paving the way for reentry services, and discuss the federal solutions needed to ensure everyone has a safe place to call home.






