


Budget Overview

Advocacy Tips

- Crafting the narrative and tailoring the message:
 - Who is your audience? Local stories and data go a long way.
- Reaching out to your lawmakers:
 - Multiple points of entry: in-district meetings, site visits, media
- How to prepare for your meeting/visit:
 - When do you schedule? What other groups should you be connecting with? How can you elevate the profile of your meeting/visit?
- What to avoid



What you can do

Ask Congress and the Trump administration to work together to lift the spending caps for FY18, maintaining parity for defense and non-defense programs, and ensure housing and community development programs receive the highest level of funding possible.
