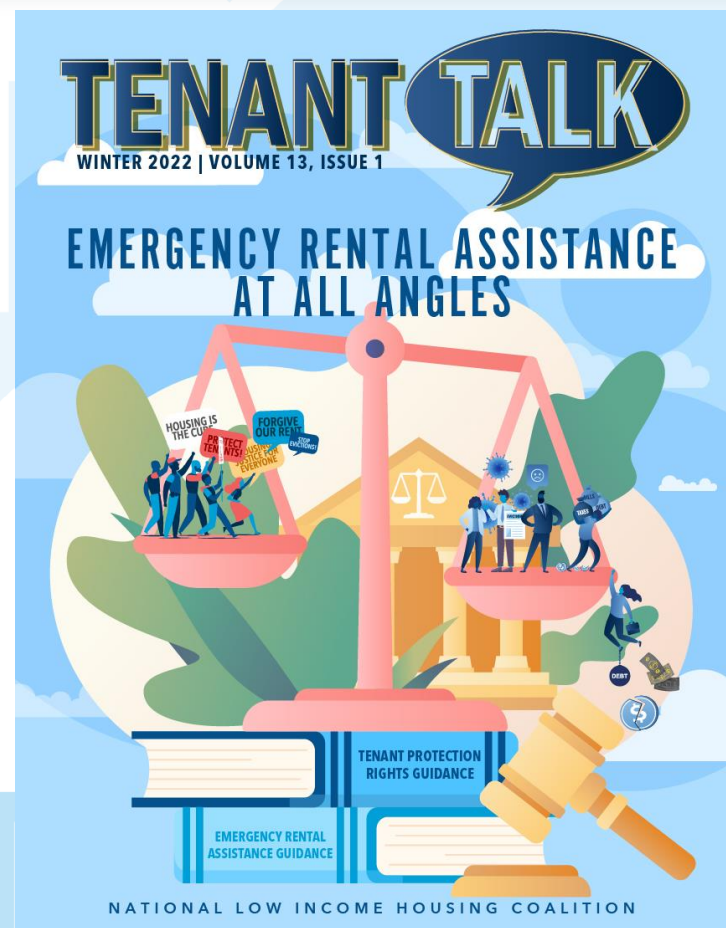


Tenant Talk is a semi-annual newsletter created by NLIHC to engage tenant and residents in housing advocacy.
