To Chair Murray, Vice Chair Collins, Chair Granger, and Ranking Member DeLauro:

We, the 2,301 undersigned organizations, write to urge Congress to **enact final Fiscal Year (FY) 2025 spending bills that provide the highest level of funding possible for vital federal affordable housing, homelessness, and community development programs, and to urge Congress to reject calls to dramatically cut domestic spending, including for these essential programs.**

We represent national, state, and local businesses, housing and community development, faith-based, disability, and civil rights organizations, as well as officials in municipal, tribal and state governments. We believe that housing is a basic human right that every American should be able to enjoy as part of a dignified standard of living.

Robust funding for affordable housing, homelessness, and community development programs is needed to address the growing affordable housing and homelessness crisis in our communities. Housing costs are rising faster than wages, our nation's affordable housing crisis worsening, and the supply of affordable and accessible housing and rental assistance has not kept pace. An estimated one in four renters spend more than half of their income on rent, and homelessness rates are rising in communities across the country. Despite the clear need, only one in four households eligible for rental assistance receives it, and the number of homes accessible to people with disabilities remains at low levels. Our nation's housing crisis impacts people of color in particular because of generations of discrimination and disinvestment.

The coronavirus pandemic accentuated the inextricable link between housing and health, and brought to light longstanding disparities in access to critical resources like affordable, accessible housing that contributed to the virus's disproportionate impact on communities of color, people with disabilities, women, older adults, LGBTQ+ individuals, and low-income people. The pandemic underscored the health and economic costs of an underfunded housing system.

As in FY24, Congress is drafting FY25 spending legislation to the parameters set by the *Fiscal Responsibility Act of 2023*, which imposes flat funding for non-defense discretionary spending

through FY24 and a 1% increase in FY25. Even flat funding for federal housing, homelessness, and community development programs – including funds imposed by budget caps, or extended through a long-term Continuing Resolution (CR) – acts as a cut, failing to keep pace with market-driven housing costs and inflation.

Flat or decreased funding reduces the number of low-income households served by these programs and prevents private owners and public housing agencies from making vital repairs. Multiple or lengthy CRs greatly delay funding for existing programs and create even longer waits for housing assistance and community investments. As millions of households struggle to make ends meet, the importance of providing increased funding for these programs, and avoiding a long-term CR, cannot be overstated.

Federal investments are critical to creating more fair and equitable communities and ensuring families thrive. Federal housing and community development programs create millions of jobs and offer critical resources to disenfranchised individuals and communities. Accessible, affordable housing has broad, positive impacts on individuals, families, communities, and the economy. Increasing and preserving access to affordable housing—especially in well-resourced areas of opportunity—helps families climb the economic ladder, leads to greater community development, and bolsters economic productivity.

Investing in affordable housing infrastructure reduces existing inequities and boosts local economies by leveraging public and private resources to lift resident earnings and local tax revenue. In fact, building 100 affordable rental homes generates \$11.7 million in local income, \$2.2 million in taxes and other revenue for local governments, and 161 local jobs in the first year. Community development assistance is vital for rural, urban, and suburban areas to revitalize distressed neighborhoods, address urgent community needs, and provide critical public services and economic development. State and local governments rely on the resources provided by the Department of Housing and Urban Development (HUD) and U.S. Department of Agriculture (USDA) to meet the housing and infrastructure needs of the communities they serve.

We urge you to enact spending bills that ensure the highest amount of funding possible for affordable housing, homelessness, and community development programs in FY 2025, and to reject any harmful proposals to dramatically cut these vital investments.
