## Office Hours Format

- Conducting an Analysis of Impediments (AI), Assessment of Fair Housing (AFH), or other form of fair housing planning document

- Reporting on any fair housing planning documents

- Community engagement
- Data analysis and local data sources for the AI and AFH
- Fair housing issues and contributing factors
