Policy Update



- The Continuing Resolution passed earlier this month:
 - funded a few agencies for the fiscal year (Ag, VA, etc)
 - directed the Executive Branch not to carry out RIFs initiated during the shutdown
- Congress has until January 30th to pass funding bills for HUD and other agencies.
 - Discussions about HUD funding are underway in both chambers
- NLIHC is calling for Congress to:
 - increase voucher funding (to avoid any reduction in vouchers)
 - protect the Continuum of Care homelessness program
 - add guardrails against more indiscriminate RIFs, impoundments, etc.
 - pass the ROAD to Housing Act within the National Defense Authorization Act
