QUICK TIPS FOR ELECTED OFFICIALS		
DO's	DON'Ts	
Do center racial equity in the design and implementation of ERA programs.	Don't impose unnecessary and burdensome requirements.	
Do prioritize households with the greatest needs.	Don't neglect the need for targeted outreach to marginalized populations.	
Do coordinate with housing agencies to make resources available to federally assisted households.	Don't restrict ERA to non-subsidized renters or bar renters living in subsidized housing from the ERA program.	
Do partner with trusted community-based organizations.	Don't lose time setting up a "perfect" program.	
Do engage landlords.	Don't penalize tenants if their landlords refuse to participate.	
Do hold grantees accountable to racial equity performance metrics.	Don't be afraid to change aspects of program design if it is not working as intended.

#### Treasury Emergency Rental Assistance (ERA) Dashboard

In response to COVID-19 and its economic fallout, many cities and states have created or expanded emergency rental assistance programs to support individuals and families impacted by the pandemic. The December 2020 COVID-19 relief package included \$25 billion in urgently needed emergency rental assistance for tenants with low incomes and established the Emergency Rental Assistance program (ERA) under the administration of the U.S. Department of the Treasury. The "American Rescue Plan Act," enacted in March 2021, provides an additional \$21.55 billion for ERA for a grand total of \$46.55 billion in emergency rental assistance.

The Treasury ERA program includes an unprecedented amount of funding for emergency rental assistance to help renters stay stably housed. The U.S. Department of the Treasury allocated the initial tranche of funds in late January 2021, as well as published several iterations of guidance from January through May. This dashboard shares information about programs and key design and implementation features that enable them to serve the lowest-income and most marginalized renters in need of housing assistance. The latest Treasury guidance strongly encourages flexible program design so that grantees may extend this emergency assistance to vulnerable populations without imposing undue documentation burdens.
