\*The total differs from \$196 million announced by FHFA because HUD receives the amount deposited into the HTF from GSEs each year. From this amount, HUD subtracts the year's mandatory sequester and adds back in the previous year's mandatory sequester. From that subtotal, HUD reduces any declined grants (e.g., from Insular Areas that decline their funds) and add back in any reallocations from deobligations from states that failed to meet commitment and/or expenditure requirements before deadlines. That amount is the total amount allocated to HTF grantees, which this year is \$214,112,537.
