IN 2021, NLIHC LAUNCHED THE END RENTAL ARREARS TO STOP EVICTIONS (ERASE) PROJECT, WHICH AIMS TO ENSURE THAT AN UNPRECEDENTED \$46.5 BILLION IN EMERGENCY RENTAL ASSISTANCE PROVIDED BY CONGRESS REACHES THE LOWEST INCOME, MOST MARGINALIZED RENTERS AND PEOPLE WITHOUT HOMES AS EFFICIENTLY AND EQUITABLY AS POSSIBLE AND TO PROTECT PEOPLE FROM EVICTION. THROUGHOUT 2022, OUR ERASE PROJECT CONTINUED TO HELP STATE AND LOCAL ERA PROGRAMS AROUND THE COUNTRY IMPROVE BY PROVIDING IMPLEMENTATION RECOMMENDATIONS AND MODELS, LEADING TO IMPROVEMENTS IN ERA DISBURSAL. THROUGH DECEMBER 2022, \$38 BILLION IN ERA HAD BEEN ISSUED TO RENTERS IN NEED. THE ERA PROGRAM HAS MADE NEARLY 10.8 MILLION PAYMENTS TO HOUSEHOLDS SINCE JANUARY 2021. U.S. TREASURY DATA INDICATE THAT 63% OF BENEFICIARIES WERE EXTREMELY LOW-INCOME HOUSEHOLDS.
