Congress:

- Final FY26 THUD spending bill
 - Increased funding for rental and homelessness assistance
 - Protections against presidential rescissions
- HFSC Oversight Hearing: HUD Secretary Scott Turner (January 21)
- Implementation of HR1

Administration:

- HUD's Disparate Impact NPRM released today (30-day comment period)
- Forthcoming NPRMs

NLIHC calls on Congress to:

- Conduct oversight of the Trump administration's assault on civil rights
- Restore civil rights investigation and enforcement capacity at HUD, HHS, Education, and across the federal government
- Enact the Tenant's Bill of Rights

Support



- Fully renew all existing vouchers
- Provide additional Tenant Protection Vouchers to successfully transition all families from Emergency Housing Vouchers
- Fund at least 250,000 new vouchers so the lowest income families benefit from HR1's expansion of Low Income Housing Tax Credit

Supply



- Improve LIHTC's reach to lowest-income families and rural and tribal communities
- Protect and expand the Housing Trust Fund
- Ensure more housing meets the accessibility needs of older and disabled people.
