ROAD to Housing Act



• The "ROAD to Housing Act of 2025" (S. 2651) includes 40 provisions related to housing supply, homelessness, disaster recovery, rural housing, and more.

• On October 10, the Senate voted to include ROAD in the National Defense Authorization Act.

• The House is considering its own housing supply package. ROAD includes many previous House bills, so at least some of its provisions will likely appear in a House bill.

Reductions in Force



- More than 400 staff across HUD received RIFs.
- 90+ of those reportedly within HUD's REAC office, which oversees inspections in HUD-assisted properties.
- HUD staff provide coordination and quality control or step in where acute need arises.
- Fair Housing and Housing Counseling offices also took significant hits.
- Treasury CDFI RIFs also of special concern to the housing sector, and threaten bipartisan momentum on housing and CDFIs in the Senate.
