

Eden Housing creates and sustains high-quality affordable housing communities that advance equity and opportunity for all.






### Home is just the beginning

- Eden works in partnership with cities and local communities to develop new housing communities
- By 2026, Eden has committed to acquiring more than 10,600 homes in communities throughout California and serve a diverse population of 25,000 low-income seniors, families, and people with special needs

# EDEN HOUSING RESIDENT SERVICES ADVOCACY

### Eden Housing defines advocacy as:

A way to create the political will to build, preserve, and to support low-income Californians.

- Housing Entitlement Process: city council meetings, planning commission, elected officials
- Regulatory: State and Federal Government
- Public Policy: bills and laws
- Individual outreach and access to services













# In 2020, Eden Housing joined a collective effort with other Non-profit housing providers and:

□ 43,057 affordable housing residents turned out to vote

69.9% percent turnout rate of the registered population

 Affordable housing properties saw an increase of 18,233 new voter registrations with Bay Area properties

 2022 Resident Survey at Eden Housing revealed 71% of residents are registered voters

# PASSAGE OF SOME LEGISILATION HAS MADE IT EASIER:

- □ 1975 Amendments to Voter Rights Act, voting materials in various languages
- 1993 National Voter Registration Act passed making registration available at the Department of Motor Vehicles, and public assistance and disabilities agencies.
- ☐ California continues to provide a safe and secure election process that allows people to engage and participate in the civic process.
- Please note requirements for voting are different in every state.





- Multisector coalition of 80+ organizations focused on increasing the supply of safe, healthy, affordable homes
- Staffed and coordinated by HNRI
- Vehicle for multiple advocacy campaigns, as well as OHOV

### **BUILDING PARTNERSHIPS**

- Nonprofit housing provider membership served as natural built-in partners, also reached out to two non-members who are part of HPC who have RI footprint
- Internally, decided to focus on five core cities in RI
  - o Central Falls, Newport, Pawtucket, Providence, and Woonsocket
  - High percent of renters, higher rates of poverty, comparitively lower voter turnout, and strong member "anchor" in communities
- Hosted an orientation in April for members in core cities to learn more about OHOV, almost all of the members who attended agreed to participate in some way
- Tried to make it easy for members to say "yes" to be an active participant, while being mindful about their capacity
  - Followed up to presentation with a draft "field plan"
- In different stages of implementing plans with members
  - Have started in-person canvassing with two members, based in Providence (West Elmwood Housing Development) and Woonsocket (NeighborWorks Blackstone River Valley)
  - Have tabling scheduled at different outreach and community events with members (community music festival, mobile shower/outreach van, block parties)









WHY COLLABORATE WITH HOUSING PROVIDERS

- To reach low-income renters
- Partner with a trusted community institution or "anchor"
- Build a culture of civic engagement
- OHOV supports goals that housing providers might have around resident engagement
- Help "build base" by providing an access point for residents to get more info about housing policy issues and to civically engage





### **CANVASSING: PLANNING**

- Decide how you will target locations and voters
- Created list of all the membership rental units in our target cities, verified physical addresses using tax assessment data, then with membership staff
- Access to voter file data extremely helpful
- Develop canvass scripts depending on your goals
- Create literature to leave behind



#### **CANVASSING: CONSIDERATIONS & LESSONS**

#### Site Prep

- Have (an) established contact(s) at the site RSCS, property managers
- Advance notice to residents can be helpful, especially in secure building
- Are there secure buildings the canvasser will need to access?
- Will housing providers want to assign a staff person to canvass?
  - Make sure that individual understands intent and is trained on any software or materials
- Bring paper copies of any forms that people might be interested in Technology
  - Training on using voter file data is essential, need to know how to run canvassing lists, create scripts, enter data....expect some process hiccups if this is new
  - Use of tablet / smartphone is beneficial to cut down on paper, make sure to test functionality
  - · Have a backup method if tech fails

#### Language

- Be prepared with materials in multiple languages
- Multi-lingual canvassers if possible



#### **CANVASSING: CONSIDERATIONS & LESSONS**

#### Be Flexible

- Some sites expressed hesitancy with doorknocking, so we are planning alternative voter engagement events
  - Coffee/donuts, workshops
- Estimating staff time for canvassing sometimes adjustments are needed
- Don't be discouraged by low contact rates, but do assess the data to determine if a different approach is needed

#### Use multiple approaches for voter engagement

- Canvassing is one method of outreach / engagement
- More beneficial when paired with other supports, such as training for site staff
  - Trainings/workshops for housing providers
  - Tabling at community or site-sponsored events
- Exploring phone / text canvassing in GOTV period (Sept/October)

#### Voting Rights and Access for Residents at HUD-Assisted Properties

The Office of Multifamily Housing Programs is making multifamily owners/agents of HUD-assisted properties aware that residents have the right to access voter registration activities and to participate in the electoral process.

Under the National Voter Registration Act of 1993, Congress has found that the right of citizens to vote is a fundamental right and that it is the duty of the Federal, State, and local accomments to promote the eversice of that right

#### Dear Executive Director:

The Department of Housing and Urban Development (HUD) has received inquiries from PHAs about what role PHAs may play in ensuring that public housing residents have access to voter registration activities and participation in the electoral process. Congress has found that the right of citizens to vote is a fundamental right and that it is the duty of the Federal, State, and local governments to promote the exercise of that right, [1]

Accordingly, the Department is sharing information on activities PHAs may engage in to ensure that public housing residents and Section 8 participants have access to this fundamental right.

Many rules about voting are set by states, so PHAs should check with their counsel to ensure that all activities are compliant with local and state law.

Permissible PHA activities include:

Housing providers can create a culture of civic engagement and provide important opportunities for residents to update their voter registrations, learn about elections, and cast their ballots. Some owners of HUD-assisted properties, however, worry that federal funding prohibits them from doing voter engagement work. Fortunately, this is not the case!

This resource provides quidance for public housing agency (PHA) directors, owners and operators of federally assisted housing, service coordinators, tenant leaders, and other advocates who are seeking to encourage voter participation and strengthen civic engagement in their communities.

#### Background

President Biden's Executive Order on Promoting Access to Voting (March 2021) affirms that the right to vote is fundamental to American democracy and that it is the obligation of the federal government to ensure that American citizens can exercise that right. The executive order directs federal agencies to evaluate ways to expand voter registration opportunities, provide information about voting, and facilitate participation in the electoral process.

In response to the executive order, the U.S. Department of Housing and Urban Development (HUD) circulated announcements to its email lists on February 9, 2022, clarifying that PHAs and recipients of HUD funding are permitted - and actively encouraged! - to facilitate nonpartisan voter engagement activities. This resource summarizes key takeaways from HUD's announcements.

### **Housing Providers Council**



- Nonpartisan group of housing developers, property managers, and resident services staff committed to boosting voter turnout among their residents
- Regular virtual meetings (bimonthly in 2024) to exchange ideas and receive trainings on best practices in nonpartisan voter engagement
- Topics have included: connecting with city clerks, transportation to the polls, language access, connecting residents with voter ID
