To Administrator Criswell,

We are community-based groups in New Jersey and national organizations who have been assisting survivors of Hurricane Ida since it made landfall in August 2021, almost two years ago. In December of last year, we wrote to you to document the many ways that FEMA's programs were failing Ida survivors and requesting that you make accommodations in the programs to extend deadlines, reopen applications, and otherwise make real efforts to ensure that FEMA's programs help more than a handful of survivors in New Jersey.

We have yet to receive a response to our December letter. We are following up now to request that you meet with us to discuss our urgent concerns about FEMA's Ida programs, which have delivered far too little help to the tens of thousands of people who should have been eligible to receive assistance. Please find our previous letter attached.

Since we last wrote to you, FEMA's March 2023 deadline for continued temporary rental assistance has now passed, with fewer than 200 survivors having received assistance under the program. This is unacceptable. For a similar program after Superstorm Sandy a decade ago, more than 10,000 New Jersey residents qualified for and received continued rental assistance. According to FEMA's own data, 44,993 people were served by its Individual Aid Program in the immediate aftermath of Ida. It is simply not credible that fewer than 300 survivors out of almost 45,000 would qualify for ongoing assistance to rebuild their lives.

HUD-funded disaster recovery programs are now starting to roll out, but these are not a substitute for FEMA's essential programs. HUD programs do not cover reimbursement of repair expenses or funding for lost household contents, which are essential forms of assistance for most survivors. Moreover, HUD programs are intended to support low- and moderate-income households. People who could have been made whole by FEMA programs should not be tracked into HUD programs that are designed for other purposes, reducing the overall amount of assistance available to New Jersey because FEMA programs didn't deliver.




