Dear Representative Turner,

We, the undersigned organizations, representing a broad spectrum of housing, homelessness, children's, and child welfare organizations, write to oppose the *Fostering Stable Housing Opportunities Act of 2017*, despite modifications to the bill. While we share your goal of helping our most vulnerable – including youth aging out of the foster system – find stable and safe housing, we remain deeply concerned that the bill would impose new burdens – the first ever for individuals who rely on federal housing assistance – including work, education, training, and self-sufficiency requirements. The modifications made to the bill do not cure its significant flaws.

As currently written, the *Fostering Stable Housing Opportunities Act* directs public housing agencies to impose a combination of work, education, and training or self-sufficiency requirements on youth aging out of the foster care system as a condition of receiving housing assistance. The bill no longer expressly requires youth to work a set number of hours each week to maintain their housing assistance, however, the HUD Secretary could establish hourly education and training requirements through regulation. As an alternative to imposing education and training requirements, public housing agencies would be required under the bill to make participation in HUD's Family Self Sufficiency (FSS) programs mandatory for youth as a conditioning of receiving housing assistance.

While the bill provides a grace period for individuals who are unable to meet these requirements, the *Fostering Stable Housing Opportunities Act* sets a troubling and unacceptable precedent. Federal housing programs help prevent homelessness and housing poverty and requiring households to meet new eligibility requirements is counterproductive to this purpose.

While we applaud your efforts to help provide critical supports to a population whose needs have for too long been forgotten, the *Fostering Stable Housing Opportunities Act* remains significantly flawed, despite modifications. Without further changes, we must oppose the *Fostering Stable Housing Opportunities Act of 2017.*
