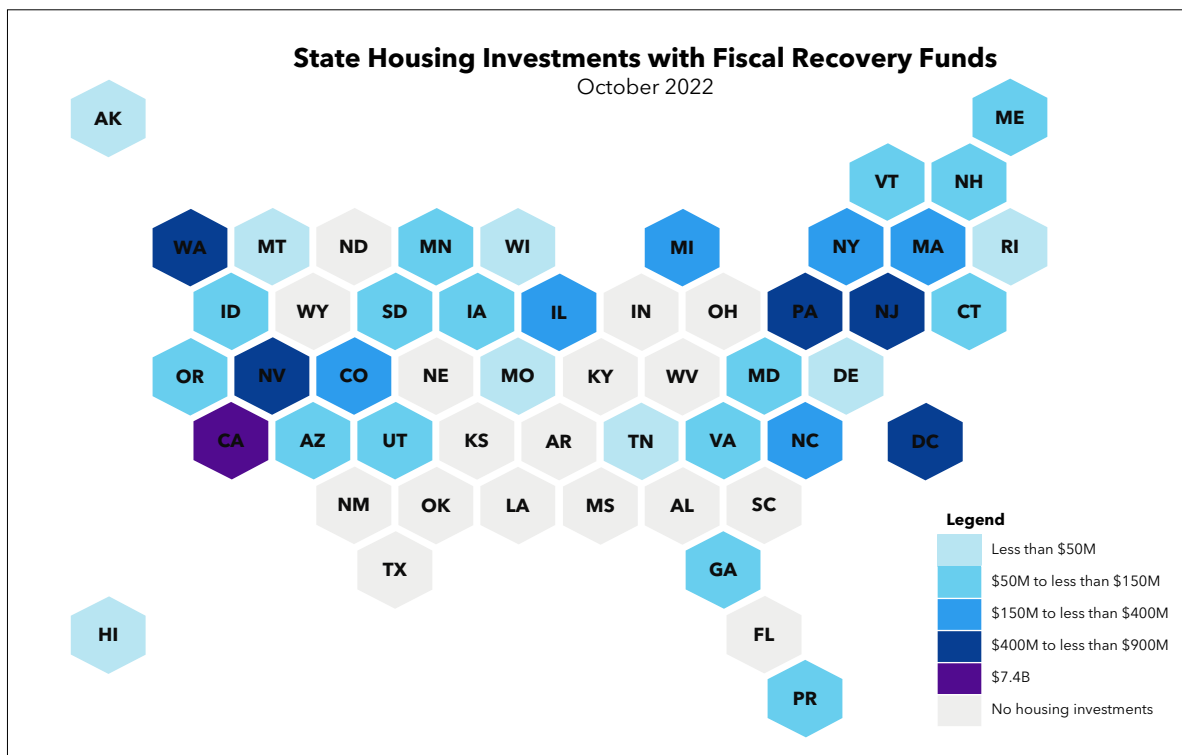


STATE AND LOCAL FISCAL RECOVERY FUND (SLFRF) HOUSING INVESTMENTS: OCTOBER 2022 UPDATE

OCTOBER 2022

In October 2022, NLIHC updated the [State and Local Fiscal Recovery Fund \(SLFRF\) database](#) for the 50 states, the District of Columbia, and Puerto Rico based on 2022 Recovery Plan Performance Reports that grantees submitted to the U.S. Department of the Treasury. States have invested an additional \$5 billion for affordable housing and homelessness prevention and services since April 2022. Based on our updated tracking, 53% of the jurisdictions tracked in our sample - including 67% of all states and over 44% of the selected cities and counties - have invested **approximately \$16.1 billion** of SLFRF for housing investments. Since April 2022, five additional states – Idaho, Missouri, Montana, New York, and Tennessee – have newly allocated SLFRF for housing services, with several others significantly increasing funding for housing projects. As of October 2022, a total of 33 states, the District of Columbia, and the Territory of Puerto Rico have invested over \$13.75 billion for housing services.



Housing Development

States and localities in our sample have allocated **approximately \$6.3 billion for housing development**, with states investing over \$5.4 billion. Between April and October 2022, state SLFRF investments in housing development increased by \$1 billion.

Homelessness Services

Approximately **\$3.6 billion has been allocated for homelessness services**, with nearly 79% of these funds invested by states. States and localities have invested over \$690 million for emergency shelters, over \$322 million for permanent supportive housing, over \$156 million for rapid rehousing, and nearly \$120 million for street outreach initiatives.

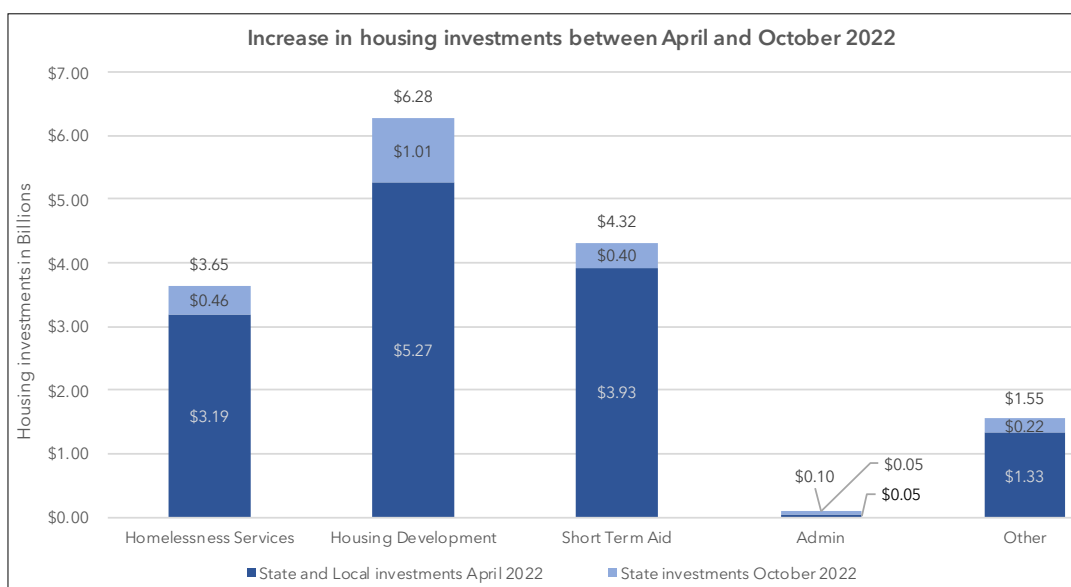
Short-Term Aid to Households

States and localities have allocated approximately **\$4.3 billion for short-term assistance to households**, including about \$1.5 billion for rental assistance, \$2.3 billion for utility assistance, \$243 million for legal aid, and \$380 million for housing stability services, such as housing navigators, housing counseling, landlord-tenant mediation, and case management.

Other Housing-Related SLFRF Projects

Approximately **\$1.5 billion has been allocated for other housing-related SLFRF projects**, including \$353 million for voucher programs; \$254 million for home repair programs for low-income families, seniors, or people with disabilities; and \$158 million for energy efficiency and weatherization projects.

States and localities have allocated over **\$101 million for administrative purposes**, such as to improve housing administration and internal capacity, strengthen data or technology infrastructure, and ensure systematic data collection and impact evaluation.
