The State of Vermont Department of Housing and Community Development (DHCD) of the Agency of Commerce and Community Development (ACCD) will conduct a public hearing to receive comments on its proposed 2016 HUD Consolidated Plan Action Plan on Wednesday, March 30, 2016 from 4:15 - 5:00 PM in the Calvin Coolidge room, at 1 National Life Drive, Deane C. Davis Building, 6th Floor, Montpelier, Vermont.

The plan constitutes the State's application for approximately \$10 million in Federal funding provided annually to the State for Community Development Block Grant, HOME Investment Partnership Program, and Emergency Solutions Grant, and describes how these funds will be used. The goals of the plan are to provide decent housing, assure a suitable living environment, and expand economic opportunities for Vermonters. Vermont may also receive funds from the National Housing Trust Fund to develop affordable housing for extremely lowand very low- income households. The state's allocation plan for using these funds, if awarded, is also included in the Action Plan.
