The Issue: Additional resources are needed to mitigate harm from the COVID-19 pandemic

The Ask: Any comprehensive response should include resources to help ensure housing stability for low-income individuals and people experiencing homelessness.

Fiscal Year 2021 Spending Bill



The Issue: Low spending caps limit funding increases for HUD & USDA programs

The Ask: The highest funding possible for affordable housing and community development programs.

The Ask: Resources to increase the supply of affordable housing for the lowest-income households.
